

Iowa Valley Community (IVC) Walking Agreement at Iowa Valley Elementary School

The member acknowledges and agrees to follow the rules and regulations set forth within this agreement and any additions or changes or amendments made by Iowa Valley Community School District. It is in agreement that Iowa Valley Community School District has the exclusive right to reject this agreement at any time.

Rules and Guidelines for Walking at the Iowa Valley Elementary Gym:

Walking guidelines:

1. Walkers must complete the Walking Agreement. A registered walker is considered to be an adult who is 18 years or older. Registered walkers are permitted to be accompanied by an occasional guest. High school students are not eligible to be registered walkers until they have graduated and all summer sports seasons have been concluded.
2. Walking privileges are restricted to the registered walker; however, he/she may supervise someone walking with them who is not a registered walker such as their child or grandchild. The registered walker is responsible for the conduct of the guest and must also follow the guidelines of the Walking Agreement.
3. No skates, bikes, rollerblades, or shoes with wheels are allowed in the new gym area. The gym is to be used for walking/running/jogging only. Strollers with rubber wheels are permitted. Wheeled walkers are also permitted.
4. A separate set of clean athletic shoes must be worn in the gym area.
5. The new Elementary gym may periodically be closed for classes, cleaning, or other activities.
6. Abuse of these policies and the walking area may result in loss of privileges.

Fees:

One-time FOB charge/lost FOB \$25 (maximum of two/family)

Hours:

School Days: 5:30-7:30 AM and 6:00-9:00 PM (subject to change due to tournaments or other planned activities)

In the evenings, walkers may/may not have to walk around the outer part of the gym avoiding students who are practicing, using balls, etc.

Non-school Day: 5:30 AM – 9:00 PM (subject to change due to tournaments or other planned activities)

Liability Waiver:

It is expressly agreed that the use of the walking area shall be undertaken by a member at his or her sole risk, and the Iowa Valley Community School District shall not be liable for any injuries or damage to any member or guest, or the property of any member or guest to be subject to claim, demand, injury, or damages whatsoever, including, without any limitations, these damages resulting from any acts or active or passive negligence on the part of the school, its successors or assigns, as well as its officers and agents, for all such claims, demands, injuries, damages, action, or cause of actions. It is specifically agreed that the school shall not be responsible or liable to members or their guests for articles lost or stolen in the gym. The Iowa Valley Community School, also, shall not be responsible or liable for loss or damage to any other property of members or their guest, including automobiles and content. It is also agreed that any damages to the school facilities or property, or to the property of any member by another member or their guest, is the sole responsibility to the offending member.

Misuse of Facility

1st offense- FOB will be de-activated for one month

2nd offense- FOB will be de-activated for three months

3rd offense- All privileges lost

I request the use of the Iowa Valley Community Elementary Gym for my recreation and for the improvement of my own fitness and athletic skills. I understand that I will be expected to dress appropriately and conduct myself in a respectful manner. Appropriate dress includes shirts for all users and clothing that is appropriate to be worn in a public school setting. I understand that the premises are under video surveillance at all times and that I am responsible for my actions.

I understand and am aware that strength, flexibility and aerobic exercise, including the use of equipment, is a potentially hazardous activity and such activities are without direct supervision. I recognize that severe injuries can occur in the gym, and I realize those severe injuries can include, but are not limited to, muscle sprains and strains, back injuries, heart attacks, permanent paralysis and even death. I realize it is in my best interest to consult a doctor before engaging in any physical training.

My participation at the Iowa Valley Elementary Gym is strictly voluntary, and free from any coercion to use the recreation facilities. I am not being paid to use the facilities. My interest is solely my own self-improvement through exercise activities available at the Iowa Valley Elementary Gym.

I further acknowledge that I will observe and follow all rules, regulations and policies of the Iowa Valley Community School District.

In consideration of the Iowa Valley Community School allowing me to use their facilities, I hereby forever release the Iowa Valley Community School District and its employees from all liability for any and all damages and injuries, including death, suffered by myself or my family in connection with the use of the Iowa Valley Community School District. I understand that my participation is entirely by my own choice and with the understanding of the risks of accidental injuries involved in any fitness activity within the Iowa Valley Elementary School. I am using the facility of my own free will and accept any and all risks associated with this use.
